**Please Note:**

If a pool barrier and/or signage is non compliant a re-inspection will be completed by Solutions in Engineering within 90 days of the order being placed with us. The inspection is reliant on the recipient of the defects report (form 26) informing Solutions in Engineering that any non-compliant pool issues have been addressed. Reinspections are charges at \$198 per inspection of a 'shared' pool, or \$278 per reinspection of a 'Holiday Letting' property's pool.

This pricelist is for a typical pool enclosure of up to 100m2 within SEQ metropolitan areas. Larger swimming pools or pools outside this area will require a quote. Please contact our office to arrange this.
